



## **Community Council Report**

This report covers progress we have made in dealing with your priorities for the Kincardine and Mearns Community Council area for the period 1 to 31 July 2020.

The report aims to highlight emerging issues in your area, to provide crime prevention advice and guidance to Community Council members and the residents you represent. Our focus is to reduce crime and disorder, help create safer communities and respond effectively to local concerns.

### **Community Policing Priorities**

#### **Antisocial behaviour, Violence and Disorder:**

There has been a significant increase in the number of Antisocial Behaviour calls within Kincardine and Mearns for the month of July, with 39 incidents reported. 6 of the 39 incidents related to youth annoyance. The majority of calls related to easing of lockdown restrictions, and the increase in house-parties.

We value the continued support of our community across Kincardine and Mearns and encourage them to contact us where there are any antisocial behaviour issues.

There were 10 assaults Crimefiles raised within the July period, which is a minor increase on the previous month. Of those 10 reported, 8 are detected and 2 have positive lines of enquiry.

There were no serious assaults reported during July

#### **Acquisitive Crime:**

There have been 7 thefts in the Kincardine and Mearns area this month, 4 are detected at this time, however 3 are still being enquired into.

There has been 1 Housebreaking this month at The Burn, Glenesk and is still under investigation by CID Proactive.

### **Road Safety & road crime:**

#### **Drink/Drug Driving**

In July there were 2 reports submitted for drug/drink drivers.

### Dangerous Driving

There has been 2 instance of dangerous driving and they have been reported to the PF for consideration of prosecution.

### Careless Driving

There have been 2 reported incidents of careless driving for the month of July both detected, 1 warned and 1 reported.

**Our #SafeSummer social media messaging has been updated to tackle alcohol, anti-social behaviour, home and water safety issues ahead of bars and holiday accommodation re-opening on 15 July.**

The #SafeSummer social media campaign helps support operational policing by communicating important messages about outdoor and water safety, home safety, anti-social behaviour and alcohol related violence to the public.

Safety messages are being communicated using Police Scotland and partner organisation social media platforms.

The campaign asks the public to consider their personal safety whether meeting friends in a bar, visiting the beach or simply sunbathing in their garden.
