### **Minutes of Last Meeting**

The minutes of the previous meeting were read. A correction was noted that it was David Evans who reported on the planting on Catterline Braes. The motion that they be approved was moved by Karen Hales and seconded by John Carr.

### **Matters Arising from the Minutes**

On the point of clarification, David Evans noted that motor-bikers illegally racing on the A92 at weekends create great danger for cyclists, including children, who may be using the road at these times.

#### **Financial Matters**

No change to the Deposit Account, while the Current Account stood at £468.46.

### **Community Fund/KMAP KDP**

- Karen Hales had been corresponding with ACC about the terms of the community benefit from St John's Wind Farm. ACC had wrongly assumed that the £2000/MW had been agreed at the planning stage. CKDCC still thought there was scope for negotiations about the amount of the benefit with Nicol Stephen, and was hoping to have a discussion together with ACC with him and then another discussion with KDP about the administration of the fund. However, ACC was not ready to negotiate with NS any more about the amount of the benefit. Phil Murray had indicated that he would like to make another presentation for ACC, and Andrew Chedburn had supported the idea.
- Cllr George Carr noted that when attending the ACC meeting, he had gained the clear impression that they did not want any more negotiations with Nicol Stephen. The latter just wanted the community to come forward with projects.
- Karen would inform ACC about CKDCC's position. On the following Thursday she would attend the KDP meeting to prepare for the AGM.

## **Matters Arising from Planning Applications**

- It was noted that Bancon had made changes to their Braehead/Newtonleys application so that water would run towards the sea. On the whole, they had paid plenty of attention to drainage.
- Peter Hales undertook to write to the planners emphasising that the proposed houses at Hillside should be in keeping with the surroundings and within an appropriate scale.
- Peter Hales had received a response to his query about the inadequate consultation time for community councils from Robert Gray, Head of Planning, who insisted that they must keep to the 14-day limit.
- George Carr mentioned that the infrastructure committee had passed a house application at Cotbank in a place that floods, but the builder would do the drainage.
- Peter Hales had attended the KM area committee meeting and reported that the Toucks application and the Mill of Ury application (supermarket and hotel plus houses) had been turned down.
- It was decided to write to the Planning Gain Officer, Jill Patterson to suggest that the CKDCC planning gain could go towards improving the School Road, Kinneff, so that children could walk and cycle to the school (combined pedestrian/cycle lane).
