2. Minutes of Last Meeting

3. Matters Arising from Minutes

- (a) It had been incorrectly minuted at the last meeting that a positive response had been noted to the Mains of Ury application however it was the application from Ury House development applying for hotel and supermarket that had been well received.
- (b) George Greiss will have his first meeting with KDP on 1/6/16

- (c) Dave Ramsay presented his Discussion Paper. In summary; establish a group/network primarily inform and support the local community, inviting each group (for example CBAG, Catkins, Cannie Act, Harbour trust, etc) to work together and help with information sharing, funding and possible money saving schemes.
