#### Police Report

#### Overview

- Crime remains generally low in the Kincardine and Mearns beat area. Since the beginning of June 2017, there have been 175 incidents reported to Police Scotland resulting in 39 Crime Reports being raised within the Kincardine area
- 13 charged following roads after 4 day (Sat-Tues) operation in Kincardine and Mearns including one drunk driver. 23 people warned
- · Watch for Doorstep crime and bogus callers
- Reports now to be submitted quarterly.



Slight increase in bogus callers – if not sure, don't let them in. Don't feel embarrassed when someone is at the door. Don't let people into the house if they need call needing help – call the emergency services on their behalf.

During weekends and sun – 'TT' racing between Catterline and Kinneff. Operation Zenith for bikes is conducted on the A92. Push bike worry in conjunction to this. Police to put out a notice to colleagues (early afternoon). NEST camp colleagues for safety van also operate on A92

Road resurface issues with bikers coming off corners towards Bervie from Kinneff due to it being slippy

#### **Roads and Transport**

In regards to any diversions, there will be plenty of other options (roads) that can be used as main diversionas take into consideration many different factors (such as heavy goods vehicles)

www.fixmystreet.com is a good means to notify Aberdeenshire council on issues with roads.

Awaiting Aberdeenshire council to fix main road in Catterline – potentially looking for better detail for the required works.

X7 standalone and 107 almost standalone when it comes to subsedies. Can bring it up that these two services are run so close in terms of time to each other.

Contractors traffic lights – who is doing it and how long should it be? Contractors are being timed how long they are actually working. ACTION - Cllr George to look into this.

Roadside of Catterline – recorded for all incidents – improves case to have central reservation changed/added to safely allow for cars to turn towards Barras
