Police Report



Report attached for April 2019

- Antisocial Behaviour, Violence and Disorder
 - 9 assaults in Apr (5 detected including two serious)
- Acquisitive Crime
 - 20 thefts in Apr (5 detected) – mostly retail crime
 - 2 housebreakings with positive lines of enquiry
 - 1 theft of a motor vehicle which has been detected
- Road safety & road crime
 - 1 person in Apr charged with drink driving
 - 1 Incident of dangerous driving reported
 - No incidents of careless driving reported in Apr
 - Four speeding tickets issued and 1 penalty for Licence issue
 - Residents in Edzell suffering from antisocial behaviour with motor vehicles
- 4 Uras Cottage – Wall damage

Drugs were discovered to the value of £200 in Stonehaven (Cannabis).

Retail crime is generally at Asda Portlethen.

- Willie Munro (Area Manager – Aberdeenshire Council) – Retired with Bruce Stewart acting until replacement confirmed

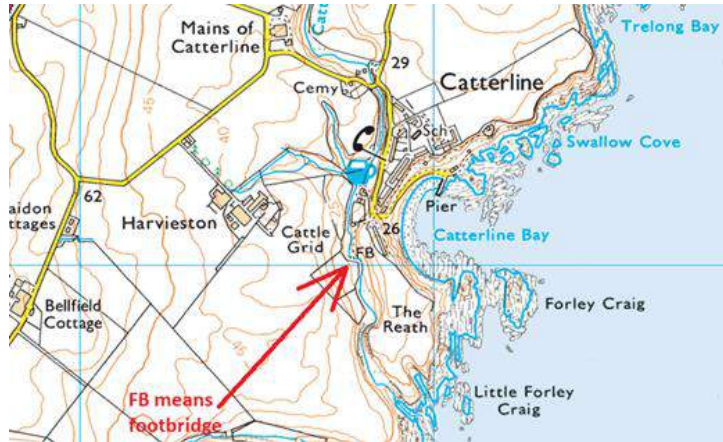
