Police Report

January Report below

- **Antisocial Behaviour(31 incidents), Violence and Disorder**
 - 13 incidents involving young people with the rest being neighbour disputes and alcohol fuelled issue
 - 7 assaults all have been detected
 - No Serious assaults
- **Acquisitive Crime**
 - 10 thefts in December including 5 incidents of shoplifting – total 6 have been detected
 - 4 house break-ins
- **Road safety & road crime**
 - 1 report of drink driving reported to the PF
 - 1 Incident of dangerous driving under enquiry
 - 4 incidents of careless driving reported, 2 of which passed to PF
 - 4 speeding ticket and a number of various tickets issued
- **Drugs – 2 drug warrants were executed in the South K&M area**



January Police Report

Several break-ins in St Cyrus – Perpetrators caught, from Motherwell.

Following the accident and subsequent road closure on the A90 near Fourdon on the 18th February, the traffic chaos on local roads in the area was unacceptable. Diversions needs to be coordinated properly when these type of incidents happen.

Community Funding and KDP

- St. Johns Hill Wind Farm opens 1st March for applications until 31st May (£15,636.40)
- KPD looking into possibility of a 'retro' application for monies already spent by the Catterline Gala by that time

The Scottish Government has awarded the first tranche of funding from the Scottish Crown Estate (Marine) Coastal Communities Fund to local authorities. Aberdeenshire Council has been awarded £328,314 for 2019-20. It was suggested that some of this money could be used to benefit projects in Catterline, in particular to combat coastal erosion and for the pier.
