# Police Report



May Police Report

May report as per below;

- **Antisocial Behaviour, Violence and Disorder**
  - 61 calls related to antisocial behaviour, 16 related to youth disturbances
  - There were 7 assault Crime Files raised within May with 4 being detected
  - There was 0 serious assaults reported
- **Acquisitive Crime**
  - 15 thefts in Kincardine and Mearns with 6 still being investigated
  - Of note was theft of £35k car which was used in a crime spree – person responsible was apprehended
- **Road safety & road crime**
  - 1 instance of driving under the influence of alcohol, they have been charged and reported for consideration
  - 2 Incidents of dangerous driving which are both detected and reported
  - 5 incident of careless driving with 2 still being investigated
