#### **Coastal Path Update**

MERCAT (Mearns Coastal Trail) – Formed approximately 5 years ago to look into the possibility of a coastal path throughout the Mearns area. The Lord Lt. Alastair Macphie asked for the path to be considered as part of HRH Jubilee and to go between St Cyrus and Aberdeen. They are currently concentrating on the Inverbervie to Stonehaven section.

As part of this plan, MERCAT are engaging with the communities and want to know what we think about it. They also want to support other groups to do the same and suggest it works best to do it in phases. It does not necessarily need to be a tarmac path as there are lots of natural solutions. Also looking at heritage opportunities along the route such as story boards. Currently mostly locals use the existing paths. They are currently surveying the remaining potential routes to identify land owners, engage with them and price up options. The southern gully of Catterline is a challenge due to it's geograthy. Crushed stone paths are not allowed in regards to farmers subsidies. Coastal Communities fund could be used for path applications. It was also mentioned that over the years, there are been numerous 'lost villages' along the coast. The crown estate money is also another option for funding. Once the paths are completed, there would need to be a maintenance plan with volunteers looking after them. It was recommended to walk south of Johnshaven to understand the work that has been conducted.

Therefore MERCAT is looking for the Community Council support and volunteers.

An option could be to write to MSP (lobby) asking for technicalities for paths in the

Agricultural bill currently moving through.

Requesting updated statement for next news letter. Gordon Ritchie deputy lord Lt. 'Opportunity North East' look at tourism which this path falls under. Question was raised how the pathways interact with nature and this has been and is being considered.

# **Planning Applications**



#### **Key Application Points**

  - Consultation feedback request from Aberdeenshire Council regarding the Installation of Battery Energy Storage System (ref: APP/2022/2676)

Question was asked if it is permitted for steadings to be demolished.

Aberdeenshire Council has previously applied for more housing allowance than had been allotted but despite this, still seems to be a demand for houses in Aberdeenshire Councils area as properties continue to be sold.

#### **Roads and Transport**



- Signage erected, although the final sign, which has been fabricated, cannot be installed until Aberdeenshire Council has installed the dead-end sign at the top of the harbour road.
- Harbour road repair funding from the Coastal Communities Fund 2022/23 and the Kincardine and Mearns Area Committee Budget has now been confirmed. The work requires to be completed before the end of March 2023 and will be carried out by Hammerfield Contractors.
- The pot holes on the access roads to the village are getting progressively worse

#### Catterline Braes & Operandum

- There was a landslip at the Nature Based Solution below the harbour road car park. The slip was reported through the CoastSnap station on Boxing Day, and further slippage has been observed since then. GCU have been informed and a post-mortem plan is being formulated.
