October local report;

Planning Applications



Key Application Points

 First public consultation for new battery storage facility at Upper Westown took place on 22nd Nov. The second consultation event in planned for 10th January at Kinneff Village Hall.

Concerns over the potential for the battery storage to go on fire – it was mentioned at the consultation that they planned to use water demonstrating they do not fully understand this aspect. This comes with it's own concerns and they were asked if SEPA had been consulted. Brings about additional concerns if the Aberdeenshire Council planning team understand these potential issues for these unusual applications.

Question was asked, does the battery have the capability to operate downstream of the supply so they can continue to supply if there is a power cut upstream?

It was also noted that it seems Aberdeenshire Council becoming 'fair game' for wind turbines.



Correspondence

Also noted was ever since someone was sadly lost in the floods at Marykirk, Aberdeenshire Council are taking note and looking to improve resilience for the region.



Roads and Transport

- Still awaiting feedback from Aberdeenshire Council regarding A957/A92 junction
- Increasing number of potholes appearing in the area and are growing in magnitude. This includes ones on the 'National Cycling Route 1' and could therefore have more serious impacts. This was highlighted by a cyclist who fell after hitting a pothole on the 26/11/23 who was needed to be driven home after
- Lower North Water Bridge closed until 8th December for repairs between 10am and 3pm
- Safety work (on A92 at Glaslaw interchange continues till 10th December with temporary traffic lights in place.

Some potholes have been repaired near the Mill of Uras, however, the roads around Catterline are getting progressively worse with some seriously large ones now in place.

Lower North Water Bridge repair work has been extended by an additional week

• Intervention slipped shortly after our meeting in October – damage due to 'under mining'



Coastal Communities fund should be utilised as much as possible with consideration for a wider project potentially between Catterline, Inverbervie, Gourdon and Johnshaven.

Rock Armour seems to be a good long-term solution used in many different locations. Difficulty remains who can perform the work required to progress this?

Thursday 30th Nov – Aberdeenshire Council infrastructure Meeting to be held with considerations for removal of Waste Recycling Centre barriers

New recycling centre to replace the Suez facility to start rebuilding next year.

All Aberdeenshire Council glass points (over 400) gets shipped to Wales and cost £1.1M compared to revenue of £92k

Waste Management meeting week commencing 4th Dec focusing on Asbestos and Tyres issues.

KPD have set up 3 new community cafes operating throughout the area Mearns area.

Eeva-Kaisa Arter confirmed that she will step down in March as our community representative to KDP. A replacement doesn't necessarily have to be from the Community Council but should come from the area. There are usually around 4 meetings a year,.

It was commented that it is perhaps a good idea for KDP to visit the Community Council periodically. ACTION Duncan – contact KDP and ask for them to attend meeting at their convenience.
