Planning Applications

Key Application Points

 Concerns regarding new battery storage facility at Upper Westown from the Barras community

Battery Energy Storage System – Upper Westown – the proposed location is 2km away from the Fiddes substation. There are already multiple 49MWhr sites at Fiddes already (3 in total). The 49MWhr seems a consideration of peace meal approvals using clause 36 and seems a way to circumnavigate the application system.

In regards to the Upper Westown site, the British Geological Society (BGS) say it is peat bog area. SEPA not aware it is a flood plane as they only look at larger flood planes) There was a fire at a site in Liverpool which took 60 hours to get under control. There will only be one container of water at the site which will probably last 10 mins if there was a fire at Upper Westown. The watermains is inconsistent as experienced by the locals to the site so can no be relied on. The fire hazard is therefore of significant concern.

It was also commented that the site is next to woodlands and nesting Barn Owls (amongst other types of birds).

Batteries will need constant air conditioning adding to noise pollution. Also, the batteries will last for around 10 years and will therefore need to be replaced at least twice given consideration of a 25 year life span of the site

A new law in England for Lithium battery storage requires HSE, fire services and environmental considerations prior to approval and it seems like the Scottish planning application process is outdated.

Land looks to be an opportune purchase by a capital investment company – perhaps to buy cheap and sell expensive.

The electricity will be no use for local residence as it wouldn't continue to provide power

should there be a disruption in supply.

It was believed that Aberdeenshire Council doesn't really have a full understanding of the implication of battery storage sites and there is limited guidance from the Scottish Government.

It was asked if the pylon culminative policy could be used for this application policy?
