The Friends of the Creel (FOTC) are investigating means of keeping the Creel Inn open. A community buy out is a potential option, that would retain the Creel as an asset for the use of residents and visitors.

FOTC has a formal constitution and a steering committee. The organisation has joined the Plunkett Foundation and is investigating routes to community ownership.

FOTC has expenses, including Plunkett Foundation Membership, expenses incurred by steering committee members, and a professional valuation of the Creel as a business.

FOTC is exploring various avenues to secure funding, e.g. grants, a share issue, etc. However, the organisation need funds now to cover immediate expenses.

Given the importance of the Creel to the local community (as evidenced by a survey conducted by FOTC), the CKDCC is in favour of supporting FOTC in their efforts to assess the feasibility of acquiring and running the Creel as a community resource, and the CC agreed that this cause meets the criteria for FOTC to apply for funding form the Upper Criggie Wind Farm fund.

ACTION Piet: Send the Upper Criggie Wind Farm fund application form to Phil Murray in his role as a member of the FOTC Steering Committee. The CC will address any application at the next scheduled business meeting, or convene a specific online meeting to consider it.
