Updates as follows

- 1. Awaiting Phil to attend next available meeting
- 2. Ongoing but is being communicated where practical
- 3. Chris confirmed he has spoken with most of the residents around Mill of Uras and all so far have been in agreement with the proposed location of the Defibrillator attached to his house. Also confirmed that he will be happy to provide the equipment with power.
- 4. The school are currently using portable 'Clevertouch Screens' rather than fixed equipment (which could get damaged in the main hall from various potential activities). Therefore Mrs Fowler has passed on our details to the IT department to seek guidance as to what CKDCC can provide and to ensure compliance.



Coastal path is a 140 miles stretch running from Angus in the South to Cullen in the North. In regards to the local section of the path, a few sticking points with some of the land owners remain at Johnshaven, North of Stonehaven and around Catterline.

The path route which currently avoids the land where issues remain is largely complete. Plan is to get to Kinneff Old Church and weave way to Todhead and then on the coast to Catterline. It was noted than livestock farms are generally trickier to navigate than arable farmland. The path will be arriving in the village around the water works area. Leaving the village North remains under consideration with an alternative to use the road. Crawton area is okay with only RSPB approvals still needed then the path is good to Dunnottar (still need approvals from them also) and how to deal with the area around the war memorial.

The next Local Development Plan could be a consideration for making land available for this path.

Wind farm funding in the future will certainly be required for things like signs and fence posts/installation. Also for a bridge and stairs around the den up to the water works in Catterline.

As things stand, the path might need to utilise the road on sections but this can be changed in the future should circumstances improve.

James and Caspar asked our opinion on if the footfall in Catterline should be on the coast side or on the road to which it was agreed that the coastline has a significant viewing advantage.

Car parking remains a concern in the area. Considerations for where the 'access points' to the path throughout the route are currently being thought out. Catterline could be a starting point/end point if the Creel was open, with parking available at Catterline Primary School outside school hours.

Other consideration:

• There could be possible land that could be purchased in Crawton.

- Public toilets consideration one will be placed between St. Cyrus and Johnshaven as a trial.
- Crawton has a dangerous junction with the A92.

James and Caspar are also looking for volunteers for activities such as ranging (walking the path regularly) and ongoing required maintenance.

It was requested to have a copy of the proposed route forwarded to CKDCC.
