

### **Roads and Transport**

- 40 mph limit implemented at A92/A957 junction
- Emergency Closure of B974 Cairn O'Mount road at Spittal Burn Bridge- road reopened on March 14.
- Closure of C21K Between Nether Pitforthie and Bridgend
- For 1 Day on Wednesday 7th May 2025 Diversion via C21K B967
   A92 C21K and vice versa (this is the road that runs past Lewis Grassick Gibbon's boyhood home Barras to Arbuthnot)
- U81K closed and reopened at Mill of Uras
- Minor timing changes to X7 bus service and additional stops at Cowie (southbound) and south end of Inverbervie (both directions).

### **Catterline Braes**

- Encouraging meeting held with "InsepraBALL" developer
- 100 spheres already fabricated, but never deployed
- Deployment methodology statement and indicative cost estimate to be developed
- Explore funding options and discuss with Aberdeenshire Council



 Funding application submitted to St John's Hill Wind Farm Community Fund, for GCU to assist CBAG to investigate and remediate the two most recent landslips (Apr 2024 and Jan 2025)

- There is no university funding for Glasgow Caledonian to assist, hence an application has been made for St Johns Hill Wind Farm funding.
- Aberdeenshire Council should be assisting with work to stabilise the braes by facilitating and providing seed funding, etc. George Carr to copy relevant correspondence to Aberdeenshire Council.
