Chairman's Address

- My thanks to everyone in the Community Council for signing up and ensuring the continuation of the group for the three-year term
- Platinum Jubilee Coastal Path project is progressing although preferred route not yet achieved
- Defibrillators have been maintained with plans progressing and funds ringfenced for one to be installed at Mill of Uras
- Discovery of the areas very own secret bunker at Bervie Brow



Chairman's Address

- Continued concerns regarding the policies and rules surrounding planning applications for Battery Energy Storage Systems (BESS)
- The planning application for the erection of a visitor centre at Dunnottar Castle was refused on the basis of the housing development associated with it did not meet certain policies but other options remain to try to progress
- Observed the creation of Catterline Community Benefits Society (CCBS) to maintain and improve the local community life.
- Kinneff School continues to be mothballed with consultations taking place for what happens next



Chairman's Address

- A surprise introduction of 40 mph limit implemented at A92/A957 junction but still no sign of improved road markings especially given this change
- £300 pounds awarded directly from CKDCC to Catterline School for Christmas festivities
- St. Johns Hill Wind Farm was well subscribed too with multiple organisations awarded funds from our area
- Upper Criggie Wind Farm has been drawn down to assist in defibrillator maintenance, Catterline Braes Action Group (CBAG) and major support for CCBS
- Thanks again to all Community Councillors and Aberdeenshire Councillors for their time and continued dedication to CKDCC!

The meeting agreed to give a £25 pound gift voucher to Carmel Vaughan as a token of thanks for verifying the Community Council Accounts.
