CBS UPDATE

Phil Murray provide an update on the Community Benefit Society,

- The CBS was formed to explore the possibility of taking the Creel into community ownership, and to facilitate this if appropriate. Since a tenant has taken the Creel, this original purpose is no longer valid.
- Various sums were spent on activities associated with taking over the Creel. These included subscribing to the Plunkett Foundation, various surveys, ensuring that the alcohol licence was maintained, etc.
- The CBS has continued to work to support the Creel by organising various events that take place there, etc.
- The CBS also organised the very successful Catterline Summer Festival weekend. Events included Bongo Bingo, a ceilidh, the Creelstock music festival and the Tour de Catterline bike ride. The festival realised a profit of around £2000, having received extensive support to fund the marquee used throughout the weekend.
- The CBS committee is keen to ensure that everyone in the CKDCC area is aware of the CBS and benefits from it.
- The CBS is a regulated financial entity. It may therefore be able to access funds that aren't available to other organisations in the CKDCC area. Those seeking funds should consider approaching the CBS for assistance as well as funding sources that have been used previously.
- Phil Murray will report CBS spending in due course and return any unspent funds in accordance with how funds were originally granted. Duncan Grassick and Piet voor de Poorte will speak to Scott Begg regarding whether the rules of the Upper Criggie wind farm fund can be changed so that block grants to the CBS are permissible as well as grants for specific projects.
